The Branch County Drain Commissioner will hold a Day of Review of Apportionments on the above date, time and location.

The Day of Review is an opportunity to review the tentative apportionment of benefit for each parcel and municipality within the Drainage District.

The Drain Commissioner, engineers and/or other staff members will be available to assist individuals throughout the day and make revisions to the apportionments where necessary. There is no need to schedule an appointment for a specific time on the Day of Review. The computation of costs for the Drain will also be available at the Day of Review. Drain assessments are collected in the same manner as property taxes and will appear on your winter tax bill.

Persons with disabilities needing accommodations for effective participation in the Day of Review should contact the Drain Commissioner's Office at the number noted above (voice) or through the Michigan Relay Center at 7-1-1 (TDD) at least 24 hours in advance of the Day of Review to request mobility, visual, hearing or other assistance.

Comments on the apportionment of benefits may be submitted to the Drain Commissioner in writing before the date of the day of review at 31 Division St. Coldwater, MI or [mhard@countyofbranch.com](mailto:mhard@countyofbranch.com), or comments may be submitted in writing or verbally at the day of review. Comments submitted in advance must be received by the Drain Commissioner prior to the day of review to ensure consideration.

You may appeal the Drain Commissioner's determination of apportionments to the Branch County Probate Court within ten (10) days after the day of review.

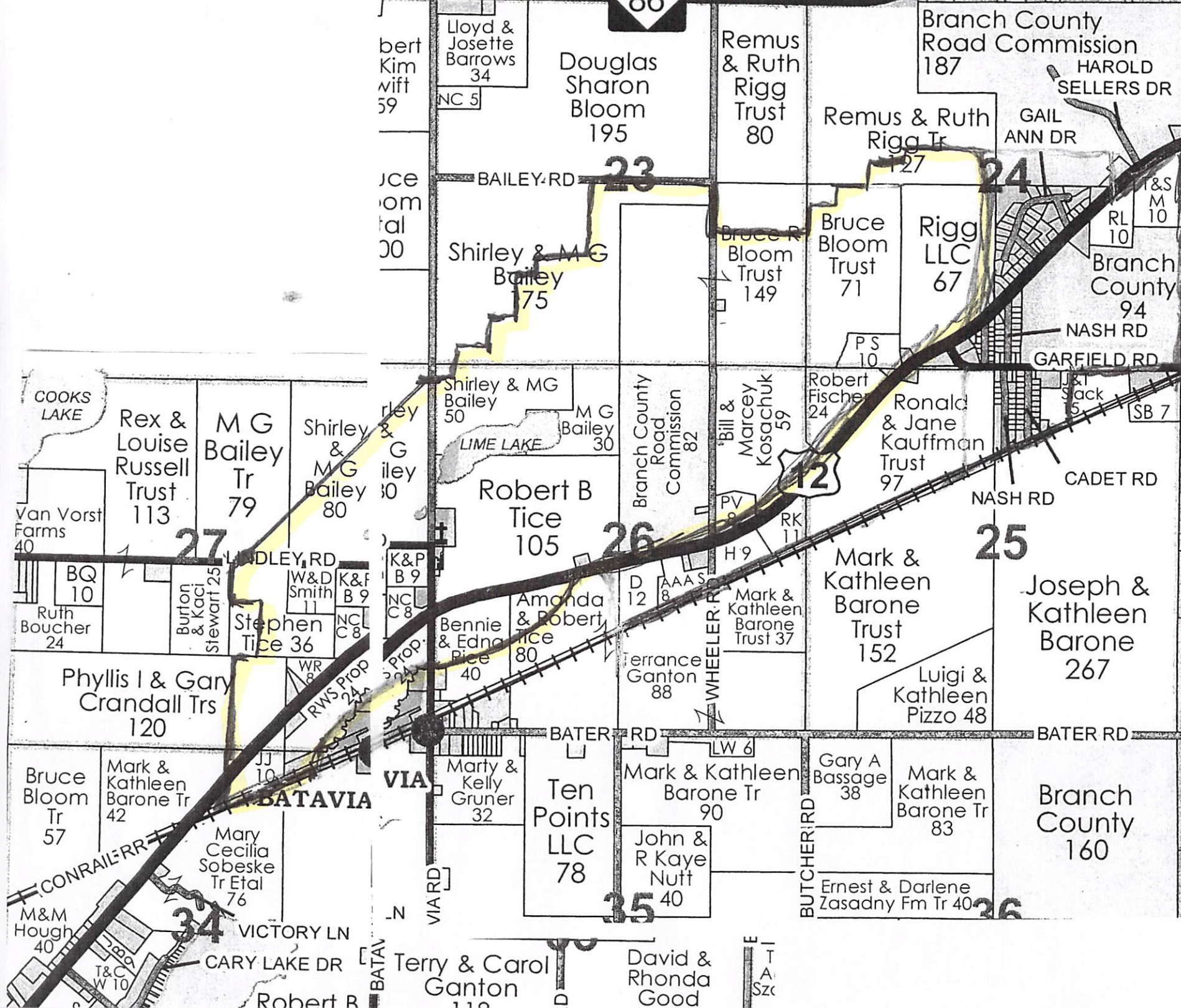
